THEREFORE BE IT RESOLVED, that the Director of Utilities and Engineering and the Central Services Committee recommend to the Mayor and City Council that the bid of Diamond Construction Company of Quincy, Illinois, in the amount of \$794,130.00 be accepted and that the Mayor be authorized to sign the necessary contract documents.

WHEREAS, the City recently sought Requests for Proposals for the analytical testing services for a two (2) year period beginning October 1, 2019, and ending September 30, 2021, with an option to extend the service contract; and,

WHEREAS, four (4) proposals were received and the Director of Utilities and Engineering has reviewed these proposals and finds them to be acceptable; and,

WHEREAS, a proposal from Eurofins Test America of Savannah, Georgia, meets the requested requirements at the cost of \$27,220.50 per year; and,

WHEREAS, funds for this service are available in the 2019/2020 General Fund fiscal year budget; now,

THEREFORE BE IT RESOLVED, that the Director of Utilities and Engineering and the Central Services Committee recommend to the Mayor and Quincy City Council that the proposal from Eurofins Test America of Savannah, Georgia, at the cost of \$27,220.50 per year be accepted.
