#### RESOLUTIONS

Resolution Authorizing Agreement For Payment In Lieu Of Taxes For Quincy Housing Authority And Quincy Ball LLC, was tabled by Ald. Uzelac for one week.

Chief of Police recommending approval that Quincy police canine Kilo be officially retired and transferred to his handler, Officer Raymond "Mike" Tyler, who is prepared to humanely care for Kilo for the rest of his life.

Comptroller to plan the new fiscal year budget with Garbage and Recycle as Enterprise Funds and to move the remaining Central Services divisions to the General Fund.

Central Services Director recommending the procurement of road salt for the 2019-2020 snow and ice season with the unit price per ton of \$69.26 and a requested amount of 200 tons, totaling in the amount of \$13,852.
