They also request "No Parking" signs be placed on both sides of Maine, 12<sup>th</sup> to 33<sup>rd</sup>, on both sides of Jersey, 14<sup>th</sup> to 16<sup>th</sup>, and on the east side of 14<sup>th</sup>, Maine to Jersey, at the end of the day on Oct. 19<sup>th</sup>. They request to close 14<sup>th</sup>, Maine to Jersey, and Jersey, 12<sup>th</sup> to 16<sup>th</sup>, for the loading of the buses and if possible, have Maine Street cleaned prior to the event. Barricades requested for intersections of: 12<sup>th</sup>, 14<sup>th</sup>, 16<sup>th</sup>, 18<sup>th</sup>, 20<sup>th</sup>, 21<sup>st</sup>, 22<sup>nd</sup>, 24<sup>th</sup>, 25<sup>th</sup>, 27<sup>th</sup>, 28<sup>th</sup>, 30<sup>th</sup>, and 33<sup>rd</sup>, for the safety of the bands participating.
