PETITIONS

By the Illinois Probation and Court Services Assoc. requesting permission to conduct a raffle and have the bond requirement waived from 4/25 to 4/27. The City Clerk recommends approval of the permit.

By the Quincy Area Chamber of Commerce requesting permission to hold the Dogwood parade on May 5th beginning at 9:20 a.m. starting on Maine at 24th, going west to 6th, north and south on 6th then disbanding. Line up of the parade will begin at 7:00 a.m. on Maine, 24th to 36th. They request "No Parking" signs be placed on Maine, 6th to 36th, and 6th, Hampshire to Jersey, at the close of business on Friday, May 4th. Rain delays are planned for 11:30 a.m. or 1:30 p.m. as the committee deems necessary on Saturday, May 5th. Organizers will be responsible for clean-up of city streets after parade.
