REGULAR MEETING

Quincy, Illinois, March 19, 2018

The regular meeting of the City Council was held this day at 7:00 p.m. with Mayor Kyle A. Moore presiding.

The following members were physically present:

Ald. Lepper moved Alderman Rein be excused from this meeting. Motion carried.

The minutes of the regular meeting of the City Council held March 12, 2018, were approved, as printed, on a motion of Ald. Havermale. Motion carried.

The City Clerk presented and read the following:

PETITIONS

By Veterans Parade Committee requesting permission to hold a Veterans Day Parade on November 10th starting at 10:00 a.m. at 12th & Maine and ending at 5th & Maine, closing streets on Maine, 12th to 5th. They are requesting Maine, 12th to 24th, be blocked for lining up of parade units at 8:30 a.m.

Ald. Sassen moved the prayer of the petition be granted and the proper authorities be notified. Motion carried.

By Quincy Montessori Co-op (Salem Church) requesting permission to conduct a raffle and have the bond requirement waived from now until 4/15th. The City Clerk recommends approval of the permit.

Ald. Sassen moved the prayer of the petition be granted. Motion carried.

A revocable permit for encroachment of city right-of-way from Electric Fountain Brewing, 503 Maine, requesting permission to place café tables and chairs, bicycle rack and movable flower planter boxes on the city owned sidewalk adjacent to the business. The City Engineer presents this request subject to six conditions.

Ald. Holtschlag moved the prayer of the petition be granted. Motion carried.

By Quincy University requesting permission to have a "Spring Glow" 5k Run/Walk on March 24th starting at 6:30 pm. with set up at 5:30 pm. The run will start at 18th & Lind, head west to 14th, south to College, east to 17th, north to Lind, west to 14th, north to Locust, south to College, east to 17th, north to Chestnut, east to 14th, south to Lind. There will be biodegradable powder tossed on individuals at 14th & Lind, 14th & Cherry, and 17th & College. Organizers will be in contact with the residents in those areas letting them know about the powder.

RESOLUTION

WHEREAS, the provision of public transit service is essential to the transportation of persons in the non-urbanized area; and

WHEREAS, 49 U.S.C. §5311 ("Section 5311"), makes funds available to the State of Illinois to help offset certain operating deficits and administrative expenses of a system providing public transit services in non-urbanized areas; and

WHEREAS, the State of Illinois, acting by and through the Illinois Department of Transportation, is authorized by 30

ILCS 740/3-1 et seq. to provide the Section 5311 grant; and

WHEREAS, grants for said funds will impose certain obligations upon the recipient, including the provision by it of the local share of funds necessary to cover costs not covered by funds provided under Section 5311.

NOW THEREFORE, BE IT RESOLVED BY THE governing council for the City of Quincy:

Section 1. That an application be made to the Office of Intermodal Project Implementation, Department of Transportation, State of Illinois, for a financial assistance grant under Section 5311 for fiscal year 2019 for the purpose of off-setting a portion of the Public Transportation Program operating deficits of the City of Quincy, Quincy Transit Lines.

Section 2. That while participating in said operating assistance program, the City of Quincy, Quincy Transit Lines, will provide all required local matching funds.

Section 3. That the Mayor of the City of Quincy, Quincy Transit Lines, is hereby authorized and directed to execute and file on behalf of the City of Quincy, Quincy Transit Lines, such application.

Section 4. That the Mayor of the City of Quincy, Quincy Transit Lines, is authorized to furnish such additional information as may be required by the Office of Intermodal Project Implementation and the Federal Transit Administration in connection with the aforesaid application for said grant.

Section 5. That the Mayor of the City of Quincy, Quincy Transit Lines, is hereby authorized and directed to execute and file on behalf of the City of Quincy, Quincy Transit Lines, a Section 5311 Grant Agreement ("Agreement") with the Illinois Department of Transportation, and amend such Agreement, if necessary, in order to obtain grant assistance under the provisions of Section 5311 for fiscal year 2019.

Section 6. That the Mayor of the City of Quincy, Quincy Transit Lines, is hereby authorized to provide such information and to file such documents as may be required to perform the Agreement and to receive the grant for fiscal year 2019.

WHEREAS, three tree service companies submitted bids for EAB treatment of city ash street trees for a 2 year treatment cycle and the low bid from Trees "R" Us, Inc., was \$33,710; and

WHEREAS, the average cost to treat a tree for EAB under the Trees "R" Us Bid is \$89.17 and

NOW THEREFORE, BE IT RESOLVED that the City Council be authorized to hire Trees "R" Us, Inc., to treat 378 City ash street trees over a two year treatment cycle at a cost of \$33,710.

FURTHER BE IT RESOLVED that the Mayor be authorized to execute a contract for the EAB treatment with Trees "R" Us for a total of 378 trees.

This Resolution shall be in full force and effect from and after its passage, as provided by law.

WHEREAS, the Quincy Police Department considers officer safety one of its highest priorities; and

WHEREAS, officer-involved shootings are dynamic, spontaneous situations that can occur at any time without warning; and

WHEREAS, the regular use of body armor is required by the Quincy Police Department and highly recommended by all law enforcement trainers; and

WHEREAS, the Quincy Police Department supplies body armor to all sworn officers; and

WHEREAS, the Quincy Police Department can purchase from the State of Illinois Bid List, where the vendor is the Uniform Den of Moline, IL; and,

WHEREAS, the Uniform Den has GH Armor HeliX Level II ballistic vests available for \$547.20 each (including uniform shirt carriers and grommet name loops); and,

WHEREAS, the total amount for nine ballistic vests and three tactical carriers is \$5,365.65; and,

WHEREAS, the Quincy Police Department has received a Department of Justice, Office of Justice, bullet proof vest matching reimbursement grant for half the total cost; now

THEREFORE BE IT RESOLVED, the Chief of Police and the Police Aldermanic Committee recommend to the Mayor and City Council that the normal bidding requirements be waived and the Police Department be allowed to purchase nine ballistic vests with carriers off the State of Illinois Bid List from the Uniform Den of Moline, IL, for a total cost of \$5,365.65.
