REGULAR MEETING

Quincy, Illinois, June 18, 2018

The regular meeting of the City Council was held this day at 7:00 p.m. with Mayor Kyle A. Moore presiding.

The following members were physically present:

Absent: Ald. Farha. 1.

Ald. Sassen moved Alderman Farha be excused from this meeting. Motion carried.

The minutes of the regular meeting of the City Council held June 11, 2018, were approved as printed on a motion of Ald. Havermale. Motion carried.

Legal Counsel: Assistant Corporation Counsel Bruce Alford.

The City Clerk presented and read the following:

PETITIONS

By Elks, 311 N. 2nd, requesting permission to waive Section 111.096 (a) (Consumption and Possession of Alcoholic Liquor on Public Streets, Alleys, and Sidewalks and Lots), Section 111.096 (d) (Permitting open liquor to leave licensed premises), on July 4th from noon to midnight for a 4th of July celebration with proper licenses being obtained. They are also requesting to block 2nd Street from Vermont to Broadway. There will be a fenced in area with only one way in and out.

Ald. Holtschlag moved the prayer of the petition be granted and the proper authorities notified. Motion carried.

By the three Quincy Kiwanis Clubs requesting permission to hold their "Peanut Day" on September 7th from 7:00 a.m. to 8:00 p.m. at various locations throughout the city.

Ald. Sassen moved the prayer of the petition be granted and the proper authorities notified. Motion carried.

By the Gem City Detachment #790 Marine Corps League requesting permission to hold their "Marine Rose Program" at Wal-Mart on June 29th, 30th and July 1st.

Ald. Sassen moved the prayer of the petition be granted and the proper authorities notified. Motion carried.

By Machinist Lodge 822 Retirees Club requesting permission to conduct a raffle and have the bond requirements waived from July 3rd to September 3rd. The City Clerk recommends approval of the permit.

By Grown N Gathered, 601 Maine, requesting permission to waive Section 111.096 (a) (Consumption and Possession of Alcoholic Liquor on Public Streets, Alleys, and Sidewalks and Lots), Section 111.096 (d) (Permitting open liquor to leave licensed premises), on June 21st, July 19th, August 16th and September 20th during the "Summer on 6th" event from 5:00 p.m. to 8:00 p.m. with proper licenses being obtained. There will be a fenced in area with only one way in and out.

Ald. Holtschlag moved the prayer of the petition be granted and the proper authorities notified. Motion carried.

By Native Wings, 138 N. Front Street, requesting permission to waive Section 111.096 (a) (Consumption and Possession of Alcoholic Liquor on Public Streets, Alleys, and Sidewalks and Lots), Section 111.096 (d) (Permitting open liquor to leave licensed premises), and Section 111.067(a) (Selling outside of licensed premises). Close Front Street from Vermont to just past Native Wings on July 4th from 5:00 p.m. to 11:00 p.m for Fireworks on the River. The Police Department recommends that the Fourth of July requests be denied due to traffic and public safety concerns.

Ald. Holtschlag moved to table for one week. Motion carried.

By Native Wings, 138 N. Front Street, requesting permission to waive Section 111.096 (a) (Consumption and Possession of Alcoholic Liquor on Public Streets, Alleys, and Sidewalks and Lots), Section 111.096 (d) (Permitting open liquor to leave licensed premises), and Section 111.067(a) (Selling outside of licensed premises). Close Front Street from Hampshire to just past Native Wings and Hampshire to the alley on July 29th from 11:00 a.m. to 8:00 p.m. for the Wing Fest. The Police Department does not oppose this request.

Ald. Holtschlag moved the prayer of the petition be granted and the proper authorities notified. Motion carried.

The petition by St. Jude Run/Quincy requesting permission to hold a run on August 3rd starting at 3:00 p.m. They are requesting the west part of the parking lot at 5th & Vermont be closed from August 1st at 8:00 p.m. through August 3rd at

3:00 p.m. They also request "no parking" signs be set up on August 3rd on the south side of Maine St., 7th to 8th and 18th to 20th, from 3:00 p.m. to 5:00 p.m. to aid in the parking of motor homes via runner stops. The run will begin at 5th & Vermont, go south on 5th to Maine then east on Maine to 54th Street, north on 54th to Broadway continuing out on 104. A police escort will be used on the routes where runners are on the street, was tabled one week by Ald. Heinecke.

Ald. Heinecke moved the petition be tabled for one week. Motion carried.

- 3) North 15th St., East and West, commencing at the south line of Winsor Dr. and extending south a distance of thirty (30) feet and at the north line of Stone Creek and extending north a distance of thirty (30) feet.
- 4) Winsor Dr., North and South, commencing thirty (30) feet west of North 15th Street and extending east a distance of sixty (60) feet.
- 5) Winsor Dr., North and South, commencing thirty (30) feet west of Stone Creek Dr. and extending east a distance of sixty (60) feet.
- 6) Stone Creek Dr., East and West, commencing at the south line of Winsor Dr. and extending south a distance of thirty (30) feet.
- 7) Stone Creek Dr., North and South, commencing thirty (30) feet west of North 15th Street and extending east a distance of sixty (60) feet.
- 8) Stone Creek Dr., North and South, commencing at the west line of Stone Creek Dr. and extending west a distance of thirty (30) feet.
- 9) Stone Creek Dr., East and West, commencing at the north line of Stone Creek Dr. and extending north a distance of thirty (30) feet.

Ald. Entrup moved the report be received and concurred in and an ordinance drafted. Motion carried.

Recommending approval of the implementation of a School Speed Zone for the newly constructed Iles Elementary School at 3111 North 12th St. The School Speed Zone will begin at a point three-hundred twenty-five (325) feet north of Highland Ln. and extend to a point one-hundred twenty (120) feet south of Koetters Lane on North 12th St. and on Hamann Ln. beginning at North 12th St. extending east a distance of one-hundred fifty (150) feet along Hamann Ln.

Ald. Entrup moved the report be received and concurred in and an ordinance drafted. Motion carried.

Recommending approval of the removal of the School Speed Zone for the former Dewey Elementary School. This School Speed Zone includes the following:

- 1) Cherry Street from Twenty-Second Street to one-hundred (100) feet east of Twentieth Street.
- 2) Chestnut Street from one-hundred (100) feet west of the west property line of Dewey School to two-hundred (200) feet east of Twenty-Second Street.
- 3) Twenty-Second Street form two-hundred twenty (220) feet south of Chestnut Street to two-hundred twenty (220) feet north of Cherry Street.

Ald. Bauer moved the report be received and concurred in and an ordinance drafted. Motion carried.
