### **PETITIONS**

By State Street Bar and Grill, 1638 State St., requesting permission to waive Sections 111.096(a), 111.096(d) and 111.067(a) on July 11, 2020 and have Live Entertainment/Public Gathering for a Bag Tournament benefiting Juvenile Diabetes. They are requesting to close 17<sup>th</sup> Street from State St. south to alley. Barricades requested. The Police Department approves as long as they follow Governor Pritzker Phase 4 Order. A Certificate of Insurance and a signed City of Quincy indemnification agreement has been provided.

A revocable permit application for encroachment of City right-of-way by The District requesting permission for businesses to place items for sale on city owned sidewalks for the Districts annual sidewalk sales from July 3<sup>rd</sup> to August 31<sup>st</sup> during normal business hours. The Utilities and Engineering Director presents this request subject to five conditions.

By the Muddy Rivers Motorcycle Club requesting permission to conduct a raffle and have the bond requirement waived from July 1<sup>st</sup> to July 31<sup>st</sup>. The City Clerk recommends approval of the permit.
