## PETITIONS

**Ward 7** By Quanada and Sammy O’Sullivan’s Irish Pub & Gaming Parlor, 123 S. 4th, requesting permission to close the alley directly off of 4<sup>th</sup> St. in between Maine St. and Jersey St. on August 5th from 9:30 a.m. to 6:00 p.m. with proper licenses being obtained. They are also requesting Section 111.096 (a) (Consumption and Possession of Alcoholic Liquor on Public Streets, Alleys, and Sidewalks and Lots) , Section 111.096 (d) (Permitting open liquor to leave licensed premises) and Section 111.067(a) Selling Outside Licensed Premises be waived. The closed area will be fenced off with only one way in and out of the building. Barricades requested.

**Ward 6** By State Street Bar and Grill, 1638 State, requesting permission to close 17th from State street south to the alley for a bags tournament on August 26<sup>th</sup> from 10:00 a.m. until 8:00 p.m. They are also requesting Section 111.096 (a) (Consumption and Possession of Alcoholic Liquor on Public Streets, Alleys, and Sidewalks and Lots) , Section 111.096 (d) (Permitting open liquor to leave licensed premises) and Section 111.067(a) Selling Outside Licensed Premises be waived. They will have outside music no later than 8:00 p.m.

**Ward 5** By Penny Roberts, AirMedCare Network, requesting permission to land the Air Evac Helicopter at the Knights of Columbus on October 25<sup>th</sup>, from 2:00 p.m. to 3:00 p.m. for Caden’s Carnival. The Quincy Fire Department will handle the securing of the landing zones during landing and takeoff.

**Ward 7** Permit for Encroachment of City Right-of-Way by For Home and Her, 644 Maine St., requesting permission to place an A-Frame sign and planters on the sidewalk in front of 642 and 644 Maine St. The Director of Utilities and Engineering presents this request subject to four conditions.
