REGULAR MEETING

Quincy, Illinois, February 6, 2017

The regular meeting of the City Council was held this day at 7:30 p.m. with Mayor Kyle A. Moore presiding.

The City Clerk presented and read the following:

PETITIONS

By the following organizations requesting permission to conduct a raffle and have the bond requirements waived: American Legion Post 37 from now through 3/3/17; Quincy Montessori Co-op/Salem Church from now until 2/9/17, and Quincy Humane Society from now through 3/25/17. The City Clerk recommends approval of the permits.

RESOLUTION

WHEREAS, the Quincy Police Department utilizes a Mobile Data Computer Communications System; and

WHEREAS, the Quincy Police Department's license and maintenance contract for the interface with Logistic Systems, Inc., is up for renewal; and

WHEREAS, the interface is needed for the Computer Aided Dispatch (CAD) System and the Automatic Vehicle Location (AVL) System; and

WHEREAS, the system allows officers to communicate with the 9-1-1 Dispatch Center, headquarters, and other officers in the field in a secure manner; and

WHEREAS, this is a sole source service as it is only provided by the vendor, and

WHEREAS, funds have been appropriated in the current fiscal year budget; now

THEREFORE BE IT RESOLVED, the Chief of Police and the Police Aldermanic Committee recommend to the Mayor and City Council that the normal bidding requirements be waived and the license and maintenance fee agreement with Logistic Systems, Inc., of Missoula, Montana, in the amount of \$8,722.00 be approved.

WHEREAS, funds for a portion of this expenditure are available in the current fiscal year budget with the remainder being budgeted for the 2017/2018 fiscal year budget; now,

THEREFORE BE IT RESOLVED, that the Director of Utilities and Engineering and the Utilities Committee recommend to the Mayor and City Council that payment to Willis of Illinois, Incorporated, totaling \$276,759.00 be approved for payment upon receipt of the invoices.
