REGULAR MEETING

Quincy, Illinois, April 17, 2017

The regular meeting of the City Council was held this day at 7:30 p.m. with Mayor Kyle A. Moore presiding.

The following members were physically present:

Ald. Holtschlag moved the absent Aldermen be excused from this meeting. Motion carried.

The minutes of the regular meeting of the City Council held April 10, 2017, were approved, as printed, on a motion of Ald. Havermale. Motion carried.

PETITIONS

RESOLUTION

Resolution authorizing application for a Public Transportation Capital Assistance Grant under the Illinois Department of Transportation's general authority to make such Grants.

WHEREAS, the provision and improvement of public transportation facilities and rolling stock is essential to the development of a safe, efficient, functional public transportation system; and

WHEREAS, the Illinois Department of Transportation has the authority to make such Grants and make funds available to offset certain capital costs of a non-profit, general public transportation

system or an IDOT Certified Public Provider transportation system providing paratransit service; and

WHEREAS, Grants for said funds will impose certain obligations upon the recipient.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF QUINCY:

Section 1. That an application be made to the Division of Public and Intermodal Transportation, Department of Transportation, State of Illinois, for a financial assistance grant under the Illinois Department of Transportation's general authority to make such Grants, for the purpose of off-setting certain public transportation capital costs of City of Quincy

for Ouincy Transit Lines.

Section 2. That the Mayor of the City of Quincy and/or Director of Quincy Transit Lines is hereby authorized and directed to execute and file on behalf of the City of Quincy for Quincy Transit Lines such application.

Section 3. That the Mayor of the City of Quincy and/or Director of Quincy Transit Lines is authorized to furnish such additional information as may be required by the Division of Public and Intermodal Transportation in connection with the aforesaid application for said Grant.

Section 4. That the Mayor of the City of Quincy and/or the Director of Quincy Transit Lines is hereby authorized and directed to execute and file on behalf of the City of Quincy for Quincy Transit Lines all required Grant Agreements with the Illinois Department of Transportation.

WHEREAS, the State of Illinois, acting through its Department of Transportation, is replacing the Cedar Creek Bridge that spans Cedar Creek on North 24th Street (IL Hwy 96); and,

WHEREAS, on December 21, 2015, the Quincy City Council authorized entering into an agreement with the State of Illinois for the allocation of Motor Fuel Tax Funds for the City's share of the bridge replacement project; and,

WHEREAS, the Illinois Department of Transportation requires the purchase of additional right-of-way to proceed with the replacement of the bridge; and,

WHEREAS, the City of Quincy maintains an active conservation easement on property located at 2403 North 24th Street; and,

WHEREAS, a tract of land containing .098 acres described in the easement lies within the proposed right-of-way required for the bridge replacement project; and,

WHEREAS, the Illinois Department of Transportation has requested that the City of Quincy release its interest in the portion of land that is described in Attachment A; and,

WHEREAS, City staff has reviewed this request and has determined that it will not cause hardship to the City; now,

THEREFORE BE IT RESOLVED, that the Director of Utilities and Engineering recommends to the Mayor and City Council that the Mayor be authorized to sign the necessary documents releasing the City's interest in the conservation easement that affects .098 acres of land that is required for the proposed right-of-way purchase.

WHEREAS, an essential part of emergency services management is the efficient and accurate recording of data; and, WHEREAS, another essential tool for the fire service is quick and accurate data and pre-fire planning retrieval; and,

WHEREAS, the Quincy Fire Department has utilized data management software from "Firehouse" since the mid 1990's; and,

WHEREAS, the department now utilizes Firehouse Web, Firehouse Desktop Maps, Firehouse Response, Firehouse Command and Firehouse Inspector; and,

WHEREAS, the cost of the annual software and licensing agreement is \$6,989; and,

WHEREAS, Firehouse software is proprietary and Firehouse is considered to be a sole source provider; and,

NOW THEREFORE BE IT RESOLVED, that the Fire Aldermanic Committee, and the Fire Chief recommend to the Mayor and City Council that the Fire Chief be authorized to make payment to Firehouse in the amount of \$6,989 to renew licenses for the current fiscal year.

WHEREAS, requests for proposals were sought for repair work to the roof portions of the entire structure and only one was received as follows:

WHEREAS, The Quincy Fire Department's Foreign Fire Insurance Board has agreed to pay the additional \$11,525 to ensure that the entire project can be completed; and,

NOW THEREFORE BE IT RESOLVED, that the Fire Aldermanic Committee and the Fire Chief recommend to the Mayor and City Council that the bid from Goerlich Roofing in the amount of \$20,900 be approved. The funds for purchase will be covered by the \$9,375 Illinois Terrorism Task Force Grant and the remainder from The Quincy Fire Department's Foreign Fire Insurance Board.
