REGULAR MEETING

Quincy, Illinois, December 18, 2017

The regular meeting of the City Council was held this day at 7:00 p.m. with Mayor Kyle A. Moore presiding.

The following members were physically present:

Ald. Holtschlag moved Alderman Goehl be excused from this meeting. Motion carried.

The minutes of the regular meeting of the City Council held December 11, 2017, were approved, as printed, on a motion of Ald. Havermale. Motion carried.

The City Clerk presented and read the following:

PETITIONS

By Stubby's Tavern, 1517 N. 3rd, requesting permission to conduct a raffle and have the bond requirement waived from now until 12/28/17. The City Clerk recommends approval of the permit.

Ald. Entrup moved the prayer of the petition be granted. Motion carried.

By the Bridge the Gap to Health Race Committee and Quincy Medical Group requesting various streets closed and no parking posted for the "Bridge the Gap to Health Race" May 19, 2018, from 3:00 a.m. – 12:00 p.m. (noon). The route, street closings and no parking areas requested will be sent to the proper authorities. Auxiliary police are requested.

RESOLUTION

NOW, THEREFORE BE IT RESOLVED that the Mayor and City Council accept the low quote of Miller Construction of \$9,750 and that the Mayor be authorized to execute the appropriate documents and contracts with the following requirements that the demolition be completed within 30 days of award of bid and be in compliance with demolition ordinance including landfill receipts, certified payroll for contractors and subcontractors, liability and workers compensation insurance for contractor and subcontractors, site security fencing and dust control.

Lepper, Reis, Heinecke, Bergman, Bauer, Ernst, Farha, Sassen. 8. Nays: Ald. VanCamp, Holtschlag, Entrup, Havermale, Rein. 5. Absent: Ald. Goehl. 1.

Written requests to speak under suspended rules by, Gordon Dobey, 617 Elm, and Tricia Crist, 6707 S. 48th, concerning the Western Illinois Veterinary Clinic/Animal Shelter.

Rules Suspended

Ald. Havermale moved the rules be suspended at this time to hear from the above individuals. Motion carried.

Gordon Dobey, 617 Elm, concerning the treatment he received at Western Illinois Veterinary Clinic. He spoke about a situation he had with feral cats tearing up his property. After making phone calls to the Animal Control and other agencies, he was steered to Western Illinois Veterinary Clinic. He stated the person there treated him, his wife and four year old daughter with disrespect by using foul language and what they would do to the cats if they left there. He suggested maybe some of the grant money that was used for taking care of these situations be given to the Humane Society as Western isn't doing what they are supposed to be doing.

Dr. Tricia Crist, 6707 S. 48th, talked about a patient that was brought in. She had pictures of the dog and said it had not been treated at the clinic. It was taken to Dr. Kaiser for treatment later. She stated they had tried to get the dog back and had asked Police Dept., States Attorney and Animal Control Officer to go get the dog. They did not get the animal. She was not happy with how all of this went down.
