- Ward 3** By NLA Quincy requesting approval for a subdivision (dividing one lot into two) of property located 3601-3701 Broadway Street under the “small tracts” provision of the Subdivision Ordinance presently zoned C2.
- Ward 5** By Good Samaritan Home requesting approval for a Special Permit for Planned Development to install additional parking stalls to serve the existing senior living facility at 2130 Harrison Street presently zoned R1A & R1C.
- Ward 1** By Tri State Investors Group, LLC requesting approval to amend a Special Permit for Planned Development to obtain a liquor license as a means to operate multiple video gaming terminals at 2600 N. 12th Street presently zoned C1B.
- Ward 4** By Bryce Rupp requesting approval to amend a Special Permit for Planned Development to allow for the 3,000 square foot cafeteria at 2435 Maine Street to be used for storage by Quincy Community Theater presently zoned R3.
- Ward 7** Special Event Application from Quincy Axe Throwing Company, requesting permission to hold Boo-vie (Movie) Night in the District on Saturday, October 22, 2022 starting at 7:00 p.m. until 10:00 p.m. at the First Mid Bank and Trust Pavilion, 635 Maine St. They request the closure of the sidewalk between 625 and 635 Maine St. for the event. The Police Department has approved waiving liquor ordinances to allow for the consumption and possession of liquor on a public sidewalk and permitting open liquor to leave the licensed premises, and the Live Entertainment/Public Gathering Application. The applicant has submitted all required documentation and approval is recommended by the Department of Utilities & Engineering.
- Wards 4, 6** Special Event Application from the Quincy Family YMCA, requesting permission to hold the annual Turkey Run on Thursday, November 24, 2022. The run/walk event will start at 8:00 a.m. and conclude at 10:30 a.m. and consists of one mile, 5K, and 10K routes that begin and end at the YMCA at 3101 Maine St. The applicant requests following street closures are requested from 7:30 a.m. until 10:30 a.m. on the day of the event: Maine St., 16th to 33rd Streets; Jersey St., 16th to 20th Streets; East Ave.; West Ave.; Aldo Boulevard, 22nd to 23 Streets; Washington St., 16th to 22nd Streets; Jackson St., 14th to 22nd Streets; 16th St., Maine to Jersey Streets; 16th St., Washington to Jackson Streets; 22nd St., Grove Ave. to Jackson St. and 23rd St., Maine St. to Aldo Boulevard. The applicant requests that Auxiliary Police be present at requested intersections and the City provide barricades for the street closures. The applicant will have signage in place directing traffic on where to enter for St. Peter’s Church services. The applicant has submitted all required documentation and approval is recommended by the Department of Utilities & Engineering.
- By ABWA Quincy Charter Chapter requesting permission to conduct a raffle and have the bond requirement waived from November 10, 2022 through February 25, 2023. The City Clerk recommends approval of the permit.
