## **REGULAR MEETING**

Quincy, Illinois, August 15, 2022

The regular meeting of the City Council was held this day at 7:00 p.m. with Mayor Michael A. Troup presiding. The following members were physically present:

Ald. Farha moved the absent Aldermen be allowed the usual compensation for this meeting. Motion carried.

The minutes of the regular meeting of the City Council held August 8, 2022, were approved on a motion of Ald. Entrup. Motion carried.

#### **PUBLIC FORUM**

Carla Gordon stated that she had concerns about the Park Districts sale of Parker Heights Park complex. She had a handout for the council

Aaron Coffman stated that he filed a Minimum Housing complaint for the property at 329 ½ Cedar. The property was inspected finding several code violations. He also had a complaint about the Inspection Department. He had a handout for the council.

Lisa Wigoda, with the Safe and Livable Housing in Quincy, is the advocate for Mr. Coffman. She stated to the council that there is a need for better oversight of the rental housing in Quincy. She had a handout for the council.

## The City Clerk presented and read the following:

## REPORT OF THE QUINCY PLAN COMMISSION

Recommending approval of a Special Permit for Planned Development to obtain a liquor license as a means to operate multiple video gaming terminals at 1034 North 4th Street, presently zoned R3, as requested with the following conditions:

- 1) That an ADA-compliant parking stall be allowed to be located along the west wall of the existing structure, near the door facing north 4th Street
- 2) That a 15' grass buffer be maintained along the eastern property line with sight-proof landscaping and/or fencing as required by city code
- 3) That the existing grass buffer be maintained along the southern property line with sight-proof landscaping and/or fencing as required by city code

Ald. Bergman moved the report be denied, seconded by Ald. Bauer, and on a voice vote the motion was carried.

#### REPORT OF THE TRAFFIC COMMISSION

Recommending the request to place "Stop" signs at the intersection of Glenayre Way and Hollister Whitney Parkway be granted. Traffic on Glenayre Way will stop for traffic on Hollister Whitney Parkway.

Ald. Freiburg moved the report be received and concurred in and an ordinance drafted. Motion carried.

#### BANK STATEMENTS OF CONDITION

The bank statements of condition from Town & Country Bank, First Bankers Trust and State Street Bank as of March 31, 2022, were ordered received and filed on a motion of Ald. Farha. Motion carried.

## SALES TAX REPORT

The report of the Illinois Department of Revenue showing sales tax collected for the month of May, 2022, in the amount of \$1,049,364.72 was ordered received and filed on a motion of Ald. Farha. Motion carried.

## HOME RULE SALES TAX REPORT

The report of the city's 1-1/2% home rule sales tax collected for the month of May, 2022, in the amount of \$1,010,082.77 was ordered received and filed on a motion of Ald. Farha. Motion carried.

#### RESOLUTION

WHEREAS, the Quincy Police Department needs to create an additional K-9 team for our K-9 Program due to the upcoming retirement of our one and only police canine, Dioji; and

WHEREAS, most dogs retire between 8-10 years of age and Quincy Police dog Dioji is 10 years old; and

WHEREAS, K-9 Program Coordinator, Sgt. Raymond Tyler, has done extensive research into various canine breeders and K-9 training academies; and

WHEREAS, K-9 Program Coordinator, Sgt. Raymond Tyler, suggests the Quincy Police Department use FMK9 for both acquisition of a new canine (dog) and for training a new K-9 handler; and

WHEREAS, a new, full service police canine (dog) costs \$7,000, which will be paid for with donated funds; and

WHEREAS, the K-9 training academy through FMK9, located in Berrien Center, Michigan, will cost \$6,500 and will be paid for with funds budgeted in the FY 23 police department budget; now THEREFORE BE IT RESOLVED, the Chief of Police and the Police Aldermanic Committee recommend to the Mayor and City Council that we purchase a new police canine (dog) from, and send a new K-9 handler through, basic K-9 academy training with FMK9 of Berrien Center, Michigan, at a cost of \$13,500.00
