RESOLUTION

WHEREAS, The City of Quincy, Quincy Transit Lines, owns and operates a fleet of 16 buses; and

WHEREAS, Gem City Ford has been taking several months to secure an engine; and

WHEREAS, we went out for quotes to rebuild the engine with local machine shops; and

WHEREAS, the City of Quincy wishes to apply for said funds to reimburse certain salary expenses.

NOW THEREFORE, BE IT RESOLVED, the Aeronautics Committee, the City Treasurer, and the Airport Director recommend to the Mayor and City Council authorization to apply for the State Fuel Tax Reimbursement Grant in the amount of \$24,704.26.
