SUBJECT: Abolition of Street Lights/Right of Way Committee

An ordinance has been drafted for your consideration that would abolish the street lights/right of way committee. The plan would be to forward street light issues in the future to the Traffic Commission and if a Right of Way issue were to come up that needed to go to a committee, it would probably be routed to the Central Services Committee. In all likelihood, there will be few right of way issues that are not handled in house by the Engineering/Utilities Department. Most rights of way now are controlled by the subdivision ordinance that was adopted around 2016. Quite frankly, I do not know of a right of way issue that has been before a city committee in the last ten years.

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE AMENDING CHAPTER 32 (CITY COUNCIL) OF THE  
MUNICIPAL CODE OF THE CITY OF QUINCY.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF QUINCY, IN ADAMS COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. That section 32.09 of the Municipal Code of the City of Quincy be and hereby is amended by deleting therefrom the following:

(S) Street lights/right-of-way: two members;

Section 2. All ordinances and parts of ordinances in conflict with the provisions of this ordinance shall be and the same are, to the extent of such conflict, hereby repealed.

Section 3. This ordinance shall be in full force and effect immediately from and after its passage and approval.
