PETITION

By Quincy Public Schools Foundation requesting permission to conduct a raffle and have the bond requirement waived from September 29th through November 3rd, 2023. The City Clerk recommends approval of the permit.

RESOLUTIONS

Engineering Manager, Director of Public Works, Director of Planning and Development, Utilities Committee, and Central Services Committee recommending approval that of the base bid along with Alternate Bid No. 3 (Alley West) and Alternate Bid No. 4 (PCC Pavement) for the 6th Street Streetscape Improvements and Maine to Vermont Project from Rees Construction Co. in the amount of \$4,768,752.

Director of Public Works and Central Services Committee recommending approval of an agreement with Evans Recycling, Inc. to reaffirm, amend, and extend the agreement for yard waste collection and disposal services. The contract payments shall be \$872,498.54 for the period of May 1, 2024, through April 30, 2025, and \$885,586.02 for the period of May 1, 2025, through April 30, 2026.

Director of Public Works, Director of Central Services, and Central Services Committee recommending approval of the proposal from Advance Stores Co., also known as Advance Auto Parts, of Raleigh, NC in the amount of \$65,550.60 for the purchase of a 4-post lift.

Engineering Manager, Director of Public Works, and Central Services Committee recommending the bid received from Complete Asphalt Service Co. of Pittsfield, IL for the 2023 Motor Fuel Tax Crack Seal Project be rejected, and the project be revised and re-bid at a later date.
